

„The joy of Erasmus”

Photo Contest – Regulations

1. An Organizer

- 1.1. An Organizer of the photo contest „The Joy of Erasmus ”(the Contest) and the founder of awards is the Rzeszów University of Technology, al. Powstańców Warszawy 12, 35-959 Rzeszów, Poland; further on „the Organizer”.
- 1.2. The contest is carried out under the auspices of the Rector.
- 1.3. The Contest is held according to the present Regulations (the Regulations).
- 1.4. The Regulations are available in the Organizer’s Department of International Cooperation, bldg. V, room 214, al. Powstańców Warszawy 12, p. V-214 and published on the web <https://dwm.prz.edu.pl/>.

2. Terms and rules of the Contest

- 2.1. The essence of the Contest is popularization of the Erasmus programme, dissemination of the project’s results within the international events Erasmus Days 2020, #ErasmusDays, #ErasmusDaysPoland.
- 2.2. Only adult students and graduates of the Organizer can partake, including both Polish and foreign beneficiaries of the Erasmus programme.
- 2.3. The Organizer’s employees, members of a jury and their relatives are excluded from participation.
- 2.4. In order to take part participants send their photographs made while the academic exchange for studies and placement under the Erasmus programme, according to the terms of the present Regulations, showing the joy of exploring visited countries, learning different cultures and customs.
- 2.5. Each participant can send not more than 4 photographs: JPG format, size 2300x3500 pixels (2:3) and resolution 300dpi recommended.
- 2.6. The technique of the photographs is at will of a participant, however a photo resulting from a serious graphic interference will be rejected. Only photos of the one exposure will be accepted. Photomontage and multiple exposure will be disqualified. It is allowed to use standard digital processing like contrast, brightness, white balance, colour saturation, sharpening and conversion of colour photos to black and white or sepia, applying colour filters, etc.
- 2.7. Photographs cannot be marked with inscriptions, watermarks, initials, ect.
- 2.8. The contest works together with the scan of filled in and signed Application Form (the outline is an attachment to the present Regulations) should be sent from 10th September until 9th October 2020 by 10.00 o’clock:
 - 2.8.1. in the secured e-mail message to the address: monikas@prz.edu.pl, at the same time a password to decode it needs to be send through other available communication channel (telephone, Messenger PRZ Interational Dept),
 - 2.8.2. a data storage device send to the Organizer’s postal address (see p. 1.1) with a postscript „Department of International Cooperation - Contest”.
- 2.9. Names of contest files should be created as follows: surname, first letter of the name, photo number, destination city, academic year of the exchange (example: Álvarez_M_1_Rzeszów_2018_2019).
- 2.10. By sending photographs the participant accepts the terms and conditions of the Contest as expressed in the present Regulations.
- 2.11. Participation in the Contest is free of charge.
- 2.12. Contest works must be done by the participant and be authorial.
- 2.13. By participation in the Contest the contestant confirms having the copyright to the photos.
- 2.14. Taking part in the Contest results in agreement for using sent photos by the Organizer to promote the Erasmus programme, the Organizer as the programme partner and the Contest free

of charge. The consent applies to publishing the photographs in the Internet, media, any exhibition space, in printing and digital materials, information and advertising materials published by the Organizer in any form. The consent is given free of charge, is irrevocable and applies without time limit.

- 2.15. Sending photos is equivalent to warranty given to the Organizer that the contest work does not breach rights of third persons, especially the photography dissemination will not lead to breaching image protection rights of the persons present on the photo, since it meets the requirements specified in the art. 81 Act on the Protection of Copyright and Related Rights (Disseminating an image requires the consent of the person depicted in it. In the case of absence of an express reservation, an authorization is not required if the person has received the agreed payment for posing. Permission is not required for the dissemination of the image of: a commonly known person, if the image was made in connection with the performance of public functions, in particular political, social or professional, or a person constituting only a detail of a whole such as an assembly, landscape, public event).
- 2.16. In the event of claims against the Organizer in relation to infringement of the rights of third parties as a result of the publication of the contest works, the Organizer shall have a recourse claim against the participant who sent the photos that do not meet the requirements specified above.
- 2.17. The Organizer rejects the contest works incompatible with the Regulations, the subject of the Contest, as well as without filled in Application Form.
- 2.18. The contest works will be evaluated by a jury consisting of: 3 workers from the Department of International Cooperation and one student all appointed by the Vice-Rector for Students Affairs and the Organizer's photographer.
- 2.19. The criteria taken into account: a/ originality and ingenuity, b/ substantive value, c/ aesthetics of the work, d/ subject compliance.
- 2.20. The jury will select 6 photographs altogether: 3 by Polish participants and 3 by participants from abroad.

3. Prizes

3.1. The jury will award Polish and foreign participants separately.

3.1.1. I prize: certificate and GO PRO action camera, valued at app. 1000 PLN

3.1.2. II prize: certificate and wireless speaker JBL, valued at app. 400 PLN

3.1.3. III prize: certificate and wireless earbuds JBL, valued at app. 300 PLN

The winners will be listed on the Department of International Cooperations's web page <https://dwm.prz.edu.pl/> and informed about victory by e-mail.

3.2. The Organizer can extend the list of prizes and award extra-statutory distinctions.

3.3. The participant can receive only one prize.

4. Final Provisions

4.1. The Organizer is responsible for correct carrying out of the Contest.

4.2. The Organizer is not responsible for potential damage or losing contest works (damaged works will not be taken into consideration).

4.3. The Organizer reserves the right to introduce changes at any time to the present Regulations as well as calling off the Contest of which adequate note will appear on the web page dwm.prz.edu.pl. If the participant does not consent to the introduced change the right to resign applies, then it is enough to send e-mail to: monikas@prz.edu.pl.

4.4. The Regulations come into force from 10th September 2020.

4.5. In matters not covered by these Regulations, the relevant provisions of Polish law shall apply. In case of any discrepancies between the English and Polish language version of the Regulations, the Polish text shall govern.

5. Personal data protection

According to Art. 13 sec. 1 and 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council as of 27th April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (i.e. General Regulation on data protection) (Journal of Laws UE.L 2016 No. 119, p. 1), hereinafter referred to as the GDPR, we would like to inform you that:

- 5.1. The administrator of your personal data is the Ignacy Łukasiewicz Rzeszów University of Technology with headquarters at al. Powstańców Warszawy 12, 35-959 Rzeszów, phone number 17 865 1100, e-mail address: kancelaria@prz.edu.pl.
- 5.2. The administrator has appointed a Data Protection Officer supervising the correctness of the processing of personal data, who can be contacted by phone +48 17 865 1775 or e-mail address: iod@prz.edu.pl or to the address of the Administrator's office in any matter regarding processing your personal data and making use of rights related to the processing of such data.
- 5.3. Your data will be processed for the purpose of:
 - 5.3.1. participation in the Contest „The joy of Erasmus” (further on “the Contest”) based on Article. 6 sec. 1 lit. a¹ GDPR
 - 5.3.2. in justified cases - asserting / defending rights or claims, pursuant to art. 6 Article 1 lit. f² GDPR.
- 5.4. Providing personal data is voluntary, but necessary to achieve the purposes for which they were collected. Refusal to provide them (refusal to consent to their processing) is tantamount to the inability to participate in the Contest.
- 5.5. Your personal data will not be disclosed to external entities (except for cases provided for by law), it will not be transferred to a recipient in a third country or an international organization.
- 5.6. The administrator may entrust the processing of your personal data to external entities acting on behalf of the Administrator, e.g. an entity providing IT services in the field of servicing and removing failures in IT systems.
- 5.7. Your personal data will be processed for the duration of the Competition, and then will be stored by the Administrator for the period of XX days / months / years or until the consent being the basis for this processing is withdrawn. In the case of asserting / defending rights or claims, your personal data will be processed for the time specified in the applicable legal provisions. Then your personal data will be irreversibly anonymized.
- 5.8. To the extent provided for by law (Articles 15-21 of the GDPR), you have the right to request access to your personal data, rectification, deletion or limitation of processing, as well as the right to object to processing and the right to transfer data, by sending a written request to the Administrator's correspondence address, or to the e-mail address monikas@prz.edu.pl.
- 5.9. Personal data processing is done on the basis of your consent, you have the right to withdraw this consent at any time. Withdrawal of consent does not affect legal compliance of processing based on consent before its withdrawal (subject to the provisions of the law). The consent may be withdrawn by sending a written request to the Administrator's correspondence address or to the e-mail address monikas@prz.edu.pl.
- 5.10. You have the right to lodge a complaint to the supervisory body (i.e. to the President of the Personal Data Protection Office) if you believe that the processing of your personal data violates the provisions of the GDPR.
- 5.11. Your data will not be subjected to automated processes of decision making (including profiling).

¹ Art. 6 sec. 1 lit. a GDPR: the data subject has consented to the processing of his personal data for one or more specific purposes.

² Art. 6 sec. 1 lit. f GDPR: processing is necessary for the purposes of the legitimate interests pursued by the administrator or by a third party, except where these interests are overridden by the interests or fundamental rights and freedoms of the data subject, which require protection of personal data, in particular when the data subject is a child.
